Steve Forrester, City Manager provided the background information on this project and City Council approved the negotiations and entering into a sales agreement back in August, 2018. It took some time for the process to go through since it was with a trust. This resolution is to finalize the purchase.

Eric Klann, City Engineer explained that this property was connected with the ASR project and the test wells were drilled and didn't perform. Since then Yancey Well failed and was rehabilitated and went from 200 gallons a minute to 750 gallons a minute and will hold us through during peak demand months during this summer. However, we put down a non-refundable deposit on this property and drilled two wells which are still okay at 100 gallons per minute. We would like to go ahead and purchase the property since there is already money invested in it and more than likely sell to our neighbors SMAF who can use the wells for dust control. We are excited to sell it and SMAF will be able to purchase it from us in a couple of months.
