### Visitors, Appearances and Requests:

#### A. Public Appearances

Seth Crawford, as representative for Flags of Prineville stated that he would like this Friday and every 3<sup>rd</sup> Friday of each year in the future, to be recognized as MIA, POW and Armed Forces Suicide Awareness. This year they would like to put POW flags out in this block using existing flag pole holes, and then to put yellow and black ribbons everywhere with property owners permission.

## A. Reading of Proclamation – Constitution Week – Mayor Roppe

Mayor Roppe read the proclamation into the record and signed it.

## **Staff Reports and Requests:**

## A. Manager's Report – Steve Forrester

Mr. Forester reported: the wetlands project groundwork is nearing completion, with planting to begin; met with CREA this week regarding rural renewable energy projects; have been asked to speak at the Redmond Rotary meeting this Thursday regarding Prineville; the city will begin having a city academy three to four times a year, and the first one is scheduled for November 2<sup>nd</sup> which will be on city finance, laws and revenue; we have completed the pavement condition index (PCI) evaluation and will prepare a report for council.

#### **Ordinances:**

A. Ordinance No. 1225 - Related to Excluding Certain Persons from Public Property (FIRST READING) - Captain Larry Seymour

Carl Dutli, City Attorney went over the two changes made to the ordinance after council review. Those changes were that a hearings officer would be appointed by the city manager and notification would be made when a person is excluded with the chief promptly entering the information into an exclusion data base.

There were discussions regarding questions and examples of behavior heard from citizens; all of the efforts being made to connect those they come in contact with to other resources for help; this is not being used as a bullying tactic; the ordinance is a tool and it can definitely be revisited in the future to see how it is working; and this will make it easier on all officers by reducing repeated response times.

Captain Seymour added that the first year after passage is usually based on communication and will try to track when someone is verbally told or paper warnings are issued.

It was also recommended that the Public Safety Committee can review how the ordinance is working.
