There were discussions regarding VA Disability income counting as income, annual award letters are issued and can be used as proof, and how VA Disability is calculated.

Council agreed unanimously to have an amendment brought back to Council for Resolution No. 1016.

Staff Reports and Requests:

A. Manager's Report – Steve Forrester

Mr. Forester reported: The Police Department was awarded a seismic grant of \$1.2 million; we have a good budget which includes \$500,000 for a new roof on the Police Department; we have been invited to talk at Bend City Club at Eagle Crest; we are hiring for open positions which included 3 dispatchers, a police officer from Warm Springs and Kathy Pucket will be starting May 1st in Finance; the budget is on track for first meeting on May 23rd; there will be a Finance Committee meeting to go over year end numbers; and the wetlands grand opening was great.

B. Committee Reports

Councilor Merritt has been to three COIC Committee meetings, but there are so many new members on that committee that there has been three weeks of orientation.

Mayor Roppe stated that the Pool Committee has started up again, so we will be getting reports on that soon.
