A. Crook County Urban Growth Boundary (UGB) Expansion and Comprehensive Map Amendment (City Planning File No. AM-2017-101 and Crook County Planning File No. 217-17-000329-PLNG) – Phil Stenbeck

Phil Stenbeck, Planning Director clarified that this is a joint public hearing for the City and the County for this application.

Mr. Stenbeck went through the background information for the applicant along with map and tax lot information.

Mr. Stenbeck went through the noticing requirements, dates and methods used for noticing.

Mr. Stenbeck stated the Planning Commission held a meeting last Tuesday the 19th, in which they recommend approval after having a joint City-County Planning Commission meeting together, and each Planning Commission recommended approval to each jurisdiction.

Mr. Stenbeck provided the background for this application and how it meets city goals, it already has an industrial designation and the city's Comprehensive Plan is consistent with the county's Comprehensive Plan.

Anne Byer, Crook County Community Development explained that last week the Crook County Planning Commission met with City of Prineville Planning Commission and they also recommended approval unanimously. There were no exceptions, no farming to consider.

Ms. Byer continued that no comments were received in favor of or against the application.

Discussions continued as to where or what direction the UGB might be expand to in the future.

Motion seconded by Judge Crawford. No discussion on motion. All in favor, motion carried.

Councilor Rodriguez made a motion to approve the Recommendation of the City Planning Commission to expand the Urban Growth Boundary to Include the Thirty-Eight (38) Acre Parcel and Comprehensive Plan Map Amendment from the County Comprehensive Plan Designation of Heavy Industrial Designation to the City Comprehensive Plan Designation of Heavy Industrial. Motion seconded. Discussion on motion. All in favor, motion carried.

Judge Crawford closed the public hearing portion of the meeting.

B. Airport Master Plan

Steve Forrester, City Manager referred to the Airport Master Plan that has been distributed. Mr. Forrester asked if anyone had any questions that could be conveyed to Kelly Coffelt, Airport Manager in preparation for adoption.

There were questions as to whether the adjacent 50 to 60 acre triangular shaped property that has a road leading up to boundary of the airport and if it could ever have access to the airport property with that road to possibly have a manufacturer such as droids. Other properties possibly having access from their property to the airport were also discussed.

There were no further questions, however if any come up they can be directed to Mr. Coffelt.
