Mayor Roppe read her 2018 State of the City Address highlighting accomplishments and challenges for the city this last year.

Councilor Rodriguez made a motion to approve the Consent Agenda as presented. Motion seconded. No discussion on motion. Motion carried.

A. Community Pool Survey – Wayne Looney

Wayne Looney provided additional information regarding the request for funding a community survey for a new pool.

Mr. Looney explained that the Crook County Court approved contributing to the survey as well as the Crook County Parks and Recreation Board, adding that \$35,000 has been spent to date gathering information.

There were discussions regarding the number of people being randomly contacted for the survey; the results of a prior Survey Monkey being combined with results from this proposed survey; how questions will be formulated; and the difference between the splash pad and the pool.

Councilor Uffelman made a motion to approve a \$5,000 contribution to Crook County Parks and Recreation for the purpose of the survey. Motion seconded. No discussion on motion. Motion carried.

B. Heart of Oregon Presentation & Request for SDC Waivers

Postponed to the next Council meeting.

Council Business

A. Annual Committee Council Appointments – Mayor Roppe

Mayor Roppe asked if anyone wanted any changes before appointing, explaining that the Deschutes Water Alliance will likely become active again.

Councilor Noves asked to be on the Finance Committee again.

Discussions continued regarding various committees, in addition to the Forest Service Collaborations which is time consuming if anyone wants to take the Mayor's place on that; removing the Business License Committee; maybe getting ideas from Councilor Papke regarding a youth advisory committee; adding the Council Governance Committee; Councilor Rodriguez wanting to be on the Transportation Committee and Councilor Beebe being on the Solid Waste Advisory Committee.

Councilor Papke stated he is happy with the committee's he is currently on.

Mayor Roppe asked everyone to review the committees and see if there is anything that interests them and appointments would be made at the next council meeting.

B. Resolution No. 1269 - Reconfirming the 8-25-15 Passing - Liz Schuette

Liz Schuette, Finance Director provided the background information stating that this was originally passed when the wetlands interim funding was taking place and now the regular funding is requiring to confirm that the resolution is still in effect.

There were no questions.

Councilor Rodriguez made a motion to reconfirm 8-25-15 passing of Resolution No. 1269 – Loan Resolution. Motion seconded. All in favor, motion carried.

C. Now 4 OSU – Cascades Coalition Request for Support

Discussions regarding the request included: having requests without time to think about them; not having a representative come in person to discuss the request; needing more information before making a decision; and if OSU were to receive the funding from the state where it would come from and what isn't going to get funding if this goes through.

Councilor Uffelman made a motion to approve letter of support for OSU. Motion seconded. No discussion on motion. Motion failed.

D. Request for Consideration of School Choice Proclamation – Mayor Roppe

There were discussions regarding this not coming to council before; it appears to be a push from a special interest group online; and sticking to the proclamation process.

Council unanimously agreed that this proclamation could not be supported.

A. Manager's Report – Steve Forrester

Mr. Forrester reported: Kelly Coffelt, Airport Manager and he did an airport update to the Central Oregon Patriots group in December which was a good meeting; Hillsboro Aviation has informed the city that they intend to continue use at the airport; the Railroad Committee and Councilor Uffelman rode on the train to the junction; a pre-con meeting was held for Facebook yesterday; Scott Smith, Street Superintendent informed him that there is an ODOT meeting on the 18th with an ODOT open house scheduled on the 25th; the Third Street Redevelopment Plan will be discussed at What's Brewing next week; the annual audit is completed with results posted online; the refunding will save the city \$3.3M over the terms; and the Planning Commission is going to review a 30 unit mobile home park.
