Councilor Rodriguez made a motion to approve the Consent Agenda as presented. Motion seconded. No discussion on motion. Motion carried.

A. Eagle Scout Project - Miles Van der Zwiep

Eric Klann, Public Works Director introduced Miles Van der Zwiep, explaining that he recently completed an Eagle Scout Project for the wetlands which will earn him a badge.

Miles Van der Zwiep went through a power point presentation that had pictures highlighting the process for the project. Miles stated that this project involved working with ODF & W and others to make sure the steelhead and salmon acclamation boxes were constructed properly. They hope to have the boxes in place by spring.

A. Ordinance No. 1241 – Establishing Offense of Chronic Nuisance Property (FIRST PRESENTATION) – Chief Cummins

A. Resolution No. 1348 – Approving Amendment 2 to Intergovernmental Agreement for Management of the Crook County / Prineville Airport (Brought back from 5/22/18 Council Meeting) – Steve Forrester

B. Resolution No. 1360 – Adopting the Section 3 Plan to Comply with 24 CFR, Part 135 of the United States Department of Housing and Urban Development Section 3

Andrew Spreadborough, NeighborImpact explained the need for adopting this to comply with the grant requirements for the Senior Center Rehabilitation project, and that this would only apply to a project that have received Federal funds to complete.

Jered Reid, City Attorney added that this is only applicable to projects completed with HUD funds.

There were no questions.

Councilor Uffelman made a motion to approve Resolution No. 1360. Motion seconded. No discussion on motion. All in favor, motion carried.

C. Resolution No. 1361 – Designating the Prineville / Crook County Enterprise Zone Be Designated for Electronic Commerce

Caroline Ervin, provided an overview explaining that this would be another designation to encourage further business within the existing enterprise zone designated area. This zone designation is competitive and is limited in the State, and Prineville was in the top position. However another city passed a resolution before Prineville could moving them up to the top position.
