Staff Reports and Requests:

A. Manager's Report – Steve Forrester

Mr. Forrester reported: that the auditors reported a clean audit with the final audit expected at end of December; Mid Oregon Personnel, a founding partner of EDCO has been interviewing candidates for Caroline's position and has it narrowed down to two candidates; there is a water summit October 21st and 22nd; he will be giving a city update to the Rotary group at Meadow Lakes at noon; there is a bio-mass summit next Friday; an application for the 230kv loop upgrade has been submitted; and Councilor Uffelman has been voted to the League of Oregon Cities (LOC) board for a 3 year term.

Mayor Roppe added how important it is to be engaged with LOC because of all they assist cities with statewide.

Councilor Uffelman provided a Finance Committee report, explaining that the committee which also includes Councilor Merritt and Councilor Noyes reviewed the proposed Resolution No. 1374 later in this agenda, and the committee recommended it be approved.

Josh Smith, Planning Director presented the staff report, explaining that this is being brought forward per council's direction at the September 11th meeting.

A. Resolution No. 1373 – Exempting from Competition a Contract for Aeration System for Plant 2 of the Wastewater Treatment Plant (PUBLIC HEARING)– Eric Klann

Eric Klann, Public Works Director presented the staff report explaining that Nexum had done a great job on plant one and it makes sense to have them do plant two so that all of the equipment is the same for efficiencies; we were able to get Energy Trust to pay for half of the first project and expect to partner with Energy Trust again for plant two.

Joe Palemo, a Prineville resident asked about the status of the hotel that was proposed for Meadow Lakes.

Mr. Forrester provided an update on the correspondence that was sent to the hotel group explaining all of the neighborhood concerns.

Paul Peterson, a Prineville resident stated he wanted to be included on any mailings.

Zach Lampert, Golf Professional reminded the audience that it would require a zone change which would require adjoining properties be notified.

Councilor Papke announced that it is potato day this weekend with three types of Oregon potatoes available and that they also donate potatoes.
