Staff Reports and Requests:

A. Manager's Report – Steve Forrester

Mr. Forrester reported: on the meeting with PGE and the strategic efforts for Bowman Dam hydro; the industrial park city well project is underway; staff is working on transmission and capacity efforts with PacificCorp; there will be a council workshop on December 11th at 5:15 P.M.

Chief Cummins came up to announce that Sgt. Larry Seymour and he were invited to attend the statewide Sheriff's conference in Bend where Officer James Young and Deputy Mitch Madden were chosen to receive an award for action taken on a trailer fire a couple of months ago; the Toys for Tots and annual food drive is starting; Police Department will be initiating the random acts of kindness program this holiday again; donations have doubled this year with Secret Santa and officers will be taking families shopping for necessities as well as children's presents; our three lateral officers were able to complete 16 week training in only 10 weeks; and we now have two full time School Resource Officer's (SRO's).

James Wilson, Public Safety IT Director provided an update to council regarding his recent request from the state to assist in communication restoration in Paradise, California, stating that they were the first Oregon strike team to arrive and had 75 engines from Oregon. Mr. Wilson went through a power point presentation that highlighted details of the fire, and pictures in the area.

Councilor Rodriguez stated that she had been asked what the activity at Meadow Lakes was.

Zach Lampert, Golf Professional responded that they are putting in a gravel over flow parking area and that the residents in the area had been notified of this.
