Council Business

A. Land Use Housekeeping Edits File No. AM-2016-100 (LEGISLATIVE PUBLIC HEARING) – Josh Smith

Josh Smith, Senior Planner presented the staff report explaining that the Planning Commission had unanimously recommended to forward to council.

Mr. Smith went through a power point presentation that detailed each of the changes proposed and the reason for the changes.

A. Manager's Report – Steve Forrester

Mr. Forester reported: What's Brewing will have some city representatives speak regarding affordable housing on February 15th; Pioneer Memorial Hospital building will have a land use hearing on February 7th; council has received emails regarding recreational marijuana and Phil Stenbeck, Planning Director is preparing a white paper outlining the history for the council arriving at their decision; the new legislative session has started and VTEL's are scheduled; and there will be a council retreat on February 11th at 9:00 A.M.

Ordinances:

A. Ordinance No. 1228 – Amending the City of Prineville Comprehensive Plan Map and Zoning Map to Change the Comprehensive Plan Designation of the Subject Property from Heavy Industrial to Residential and the Zoning Designation from Light Industrial (M-1) to General Residential (R-2). (SECOND PRESENTATION) – Phil Stenbeck

Mr. Stenbeck provided an overview of the application, explaining that the power point from the last meeting is being entered into the records as Exhibit "D". There was a copy of Exhibit "C" redistributed showing the subject property outline to scale.

Eric Klann, City Engineer referred to the intergovernmental agreement (IGA) in the agenda packet explaining that ODOT explained in depth at the first meeting in January, 2017.

Mr. Klann stated that the city is looking to open bids in November with construction starting in the spring of 2018.

Mr. Klann summarized the funding sources and that no funds were dedicated to landscaping features for the roundabout and we need to look at selecting these features for the council to decide on.

There were discussions regarding the city accepting county land and Mr. Klann referred to page 45 of the agenda packet.

Councilor Merritt made a motion to approve Resolution No. 1308. Motion seconded. No discussion on motion. All in favor, motion carried.

B. Resolution No. 1309 – In Support of a Transportation Funding Package in the 2017 Oregon Legislative Session – Steve Forrester
