#### **Ordinances:**

A. Ordinance No. 1238- An Ordinance Amending the City Zoning Map and Comprehensive Plan Map to Match the Adopted 2017 Airport Master Plan (SECOND PRESENTATION) – Josh Smith

Josh Smith, Planning Director explained this is the second presentation.

There were no questions.

Councilor Noyes made a motion to approve the second presentation of Ordinance No. 1238. Motion seconded. No discussion on motion. All in favor, motion carried.

B. Ordinance No. 1239- Adopting an Update to the City Wastewater Master Plan (SECOND PRESENTATION) - Eric Klann / Josh Smith

Mr. Smith stated this is the second presentation and can answer any questions if any.

C. Ordinance No. 1240 – An Ordinance Adding Chapters 53.10 – 53.70 to the Prineville City Code (FIRST PRESENTATION) – Mike Kasberger

Mike Kasberger, Assistant City Engineer presented the staff report stating that this ordinance will give the city the authority to enforce certain DEQ wastewater requirements for users over 25,000 gallons per day and certain categorized wastewater.

There were no questions.

Councilor Papke made a motion to approve Ordinance No. 1240 for the first presentation. Motion seconded. No discussion on motion. All in favor motion carried.

#### **Resolutions:**

A. Resolution No. 1346 – Approving a Real Estate Purchase & Sale Agreement– Josh Smith

Mr. Smith presented the staff report and power point presentation stating that this property's primary purpose will be for the future realignment of Ninth Street.

Councilor Beebe made a motion to approve Resolution No. 1343. Motion seconded. No discussion on motion. All in favor, motion carried.

B. Resolution No. 1347 – Approving Prineville Rails to Trails Project Agreement with ODOT – Scott Smith

Scott Smith, Street Supervisor presented the staff report explaining that the project is moving forward with the design phase, and that he has a verbal commitment from the ARTS program for \$95,000 towards the project.

There were discussions regarding who will maintain; the paved path being wide enough to get equipment down it for maintenance; and ODOT being responsible for overseeing the project.

Councilor Papke made a motion to approve Resolution No. 1347. Motion seconded. No discussion on motion. All in favor, motion seconded.

C. Resolution No. 1348 – Approving Amendment 2 to the IGA for Management of the Crook County / Prineville Airport – Steve Forrester / Kelly Coffelt

D. Resolution No. 1349 – Authorizing the City to Enter Into an IGA with Crook County for GIS Support – James Wilson
