

ORDINANCE NO. 628

AN ORDINANCE ANNEXING CERTAIN TERRITORY.

WHEREAS, there has been submitted to the City of Prineville a written proposal for annexation to the City by more than two-thirds of the landowners who also own more than two-thirds of the land in the contiguous territory described below which real property therein represents more than two-thirds of the assessed value of all real property in the contiguous territory to be annexed; and,

WHEREAS, Ordinance No. 627 was passed, initiating the annexation of said territory, calling a hearing and directing that notice be given thereon, and since the hearing was held at which time all objections or remonstrances with reference to said proposed annexation were considered by the City Council and since that body feels that annexation is to the best interest of the City and of the contiguous territory; now therefore,

THE PEOPLE OF THE CITY OF PRINEVILLE DO ORDAIN AS FOLLOWS:

Section 1. Annexation area. The following described contiguous territory is hereby proclaimed to be annexed to the City of Prineville:


Beginning 2818.24 feet east of the SW corner of Section 32, T 14 S. R. 16 EWM; thence, north $0^{\circ} 48' 30''$ east 243.14 feet; thence S. $89^{\circ} 05' W.$ 50 feet to point of beginning; thence, S. $89^{\circ} 05'$ West 50 feet; thence, N. $0^{\circ} 48' 30''$ East 153 feet M/L to South line County Road; thence, S. $62^{\circ} 01'$ east along same to a point; thence, S. $0^{\circ} 48' 30''$ west 145 feet to point of beginning; and also;


Beginning at a point located from SW corner of Section 32, T 14 S. R. 16 EWM; thence, east 2818.24'; thence, N. $0^{\circ} 48' 30''$ east 243.14' to place of beginning; thence, South $89^{\circ} 05' W.$ 50'; thence, N. $0^{\circ} 48' 30''$ east 145' M/L to South side of County Road; thence, S. $62^{\circ} 01'$ east along south side County Road to a point 130.91' north of point of beginning; thence, S. $0^{\circ} 48' 30''$ west 130.91' to point of beginning.

Section 2. Record. The City Recorder shall submit to the Secretary of the State of Oregon (1) a copy of this ordinance, (2) a copy of the statement of consent of the landowners in the territory annexed, and (3) a copy of Ordinance No. 627 dispensing with an election in the City on the question of annexation. The City Recorder shall also send a description by metes and bounds, or legal subdivisions, of the new boundaries of the City within ten (10) days of the effective date of annexation to the Crook County Assessor and Crook County Clerk.
