

ORDINANCE NO. 752

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN TERRITORY; DISPENSING WITH A CITY ELECTION ON THE QUESTION: FIXING A DAY FOR PUBLIC HEARING; AND DIRECTING THAT NOTICE BE PUBLISHED AND POSTED.

WHEREAS, it is found by the City Council of the City of Prineville that it would be in the public interest for certain territory below to be annexed; and

WHEREAS, the City Charter does not expressly prohibit the City from dispensing with submitting the question of annexation to the registered voters of the City;

NOW THEREFORE, the people of the City of Prineville ordain as follows:

Section 1. Annexation Area. It appears to be in the best interest the City of Prineville that the following described contiguous territory be annexed: To wit

Beginning at the Northwest corner of Steve W. Yancey Second Subdivision, as platted in Crook County, Oregon, said point being on the West line of Section 31 in Township 14 South, Range 16 East of the Willamette Meridian, thence South along the West line of said Section 31 a distance of 705 feet, more or less, to a point on the Northerly bank of Ochoco Creek, thence Southeasterly following the meanderings of said Northerly bank of Ochoco Creek to a point 486 feet North of the South line of said Section 31, thence East following along a line 486 feet North of the South line of said Section 31 a distance of 672 feet, more or less, to a point on the North and South center line of said Section 31, thence North along said North and South center line to the center of said Section 31, thence East along the East and West center line of said Section 31 to a point on the Westerly right of way line of Lamonta Road, as located and constructed, thence Northwesterly along said right of way line to a point due East of the Northeast corner of Tract 29 of said Steve W. Yancey Second Subdivision, thence West to the Northeast corner of Said Tract 29, thence West along the North line of said Steve W. Yancey Second Subidivision to the point of beginning.

Section 2. Annexation without Election. The City Council does hereby elect to dispense with submitting the question of annexation to an election by the registered voters of the City as authorized by ORS 222.120.

Section 3. Public Hearing. That a public hearing on the question of annexation shall be held at the City Hall of Prineville on August 19, 1975, at 7 o'clock P.M. at which time the registered voters of the City may appear and be heard on the question of annexation.

Section 4. Notice of Hearing. The City Recorder shall give notice of the hearing by publication once each week for two successive weeks prior to the day of said hearing in the Central Oregonian, a newspaper of general circulation within the City. The City Recorder shall further cause notice of this hearing to be posted in four public places within the City for a like period of time.

Section 5. Inasmuch as it is necessary for the health, safety and welfare of the City of Prineville that this ordinance go into effect immediately after its passage, an emergency is hereby declared to exist and this ordinance shall be in full force and effect from and after its passage by the City Council and approval by the Mayor.
