RESOLUTION NO. 824

A RESOLUTION ANNEXING CERTAIN PROPERTY INTO THE CITY OF PRINEVILLE AND REZONING SAID PROPERTY

- 1. The Council specifically finds that:
- (a) Those properties located within the Urban Growth Boundary of the City of Prineville and located within the boundaries of the Peters Road Local Improvement District Boundaries as set forth by City Ordinance No. 1034 and further described as Tax Lots 300, 307 and 308 of Crook County Assessor's Map 14-16-32 located in the SW¼NW¼ and in the E½NW¾ of Section 32, Township 14 South, Range 16 East, and Tax Lots 1600, 2200, 2201, 2202 and 2203 of Crook County Assessor's Map 14-16-29 located in the SE½SW¼ and in the W½SE¼ of Section 29, Township 14 South, Range 16 East, as shown on the map attached as "Exhibit A" to this resolution, and more specifically described in "Exhibit B".
- (b) The properties to be annexed are contiguous to the City of Prineville.
- (c) All of the property owners and electors of said property have duly petitioned the City for annexation and have thereby consented to such annexation.
- (d) The City Planning Department and City Planning Commission have duly considered the subject annexation and rezoning issues, and have recommended annexation and certain rezoning of said properties as set forth in "Exhibit C" to this Resolution.
- 2. The real property described in "Exhibit B" to this resolution is hereby annexed into the City of Prineville with the boundaries as set forth in said "Exhibit B" to this resolution and as shown on the map set forth in "Exhibit A" to this resolution.
- 3. The real property described in "Exhibit B" to this resolution is hereby rezoned to the Zoning designation shown on the map set forth as "Exhibit C" of this Resolution pursuant to the applicable provisions of the City of Prineville Zoning Ordinance No. 807, as amended.

ANNEXATION MAP




