

CITY OF PRINEVILLE RESOLUTION NO. 818

A Resolution to repay Special Public Works Fund Conditional Grant

The Council makes the following findings:

A. The City of Prineville has received a Special Public Works Fund (SPWF) Conditional Grant in the amount of \$85,384.00 to defray costs of bringing water and sewer to the Industrial Parks near the Prineville/Crook County Airport.

B. Oregon Economic Development Department has agreed that the grant money shall be deferred until the property benefited by the grant is sold.


C. The \$85,384.00 shall be repaid to the Oregon Economic Development Department on a pro rata, acre by acre basis, as property is sold according to the schedule attached hereto as Exhibit A.

Now, therefore, the Common Council hereby resolves that upon sale of lots 1 through 23 of Baldwin Road Industrial Park, the assessment described on Exhibit A for the particular lot shall be paid to Oregon Economic Development Department to defray the SPWF Conditional Grant of \$85,384.00.
