


RESOLUTION APPROVING ANNEXATION OF PROPERTY

LEGAL DESCRIPTION

A parcel of land in the Southwest one-quarter Northeast one-quarter (SW1/4 NE1/4) of Section 5, Township 15 South, Range 16 East, W.M., City of Prineville, Crook County, Oregon, more particularly described as follows:

Beginning at the Southwest corner of the Southeast quarter of the Northeast quarter of Section 5, said point also being the Southeast corner of the Plat of Prineville Acres Subdivision, City of Prineville, Crook County, Oregon, and also being the Northeast corner of the Plat of Hidden Springs Subdivision, City of Prineville, Crook County, Oregon, thence North 89°00'19" West along the North line of said Hidden Springs Subdivision a distance of 1308.42 feet to a point on the East line of Lot 2 of Block 18 of Northwest Townsite Company First Addition Subdivision, City of Prineville, Crook County, Oregon; thence North 0°04'01" West along the East line of said subdivision a distance of 523.06 feet to the intersection of the centerline of S.E. Third Street, now vacated, and said East line of Northwest Townsite Company First Addition; thence North 89°50'40" West along said centerline a distance of 39.28 feet to intersection with the East line of South Idlewood Street of said Subdivision; thence North 00°00'35" West along said East line a distance of 280.00 feet to the Northwest corner of Lot 1 of Block 8 of said Subdivision; thence North 00°00'35" West along said East line of Idlewood Street, as vacated, a distance of 20.00 feet; thence South 89°50'40" East along the South line of S.E. Second Street as now located following partial vacation a distance of 305.64 feet to the Northwest corner of that parcel of land excepted in deed recorded Deeds MF 92915, Records of Crook County, Oregon; thence South 0°19'33" West a distance of 295.31 feet; thence North 89°13'06" East a distance of 238.15 feet; thence North 0°28'51" East a distance of 291.41 feet to the South line of S.E. Second Street; thence South 89°50'40" East along said line a distance of 260.48 feet; thence South 0°09'20" West along said line a distance of 5.00 feet; thence South 89°50'40" East along said line a distance of 112.67 feet to the Northwest corner of that parcel of land as described in that conveyance to Sylvia Brock by deed recorded Book 90 at Page 114, Records of Crook County, Oregon, and being the
