

RESOLUTION NO. 610

A RESOLUTION PROVIDING FOR SPECIAL ELECTIONS TO BE HELD ACCORDING TO THE STATUTES OF THE STATE OF OREGON AND THE CHARTER OF THE CITY OF PRINEVILLE FOR THE PURPOSE OF ADOPTING OR REJECTING A LEVY OF \$131,000 OUTSIDE THE PRESENT TAX BASE; A LEVY OF \$71,038 OUTSIDE THE PRESENT TAX BASE; A LEVY OF \$105,429 OUTSIDE THE PRESENT TAX BASE; PROVIDING FOR THE BALLOT TITLES, WHICH SHALL CONTAIN A CAPTION, QUESTION AND EXPLANATION CLAUSE; PROVIDING FOR THE TIME AND PLACE OF THE ELECTIONS; AND PROVIDING FOR NOTICE OF THE ELECTION.

THE CITY OF PRINEVILLE RESOLVES AS FOLLOWS:

Section 1. Special elections to provide for a vote on a General Fund operating levy in the amount of \$131,000, a Street Fund operating levy in the amount of \$71,038 and a Parks, Recreation and Swimming Pool levy of \$105,429, all to be one-year special levies, commencing July 1, 1983. These elections shall be held and are hereby called to be held in the City of Prineville, Crook County Oregon, Tuesday, August 9, 1983. These amounts are outside the present tax base.

Section 2. The ballot titles under which these proposals shall appear are as follows:

51. GENERAL FUND OPERATING LEVY, 1983-84 FISCAL YEAR

QUESTION: Shall City of Prineville levy \$131,000 outside its tax base for the General Fund, Fiscal Year 1983-84?

EXPLANATION: The tax base for the City of Prineville is \$81,650. Any property taxes levied in excess of this amount must have specific voter approval. In order to provide certain levels of service in the General Fund, and support for this service, \$131,000 in additional tax dollars are needed. These tax dollars will help offset costs in areas such as police and fire protection, ambulance service, insurance, administration, fire hydrant rental, street lighting costs and other general operations.

If this measure is approved, \$131,000 of the taxes levied in the 1983-84 fiscal year will be financed partially by the State of Oregon.

52. STREET FUND OPERATING AND MAINTENANCE LEVY, 1983-84 FISCAL YEAR

QUESTION: Shall City of Prineville levy \$71,038 outside its tax base for Street Fund operations and maintenance, Fiscal Year 1983-84?

EXPLANATION: In order to provide operations and maintenance at a certain level, \$71,038 in supplemental tax dollars are needed for the Street Fund. These dollars, when combined with other Street Fund revenues will help offset costs in areas such as maintenance personnel, needed patchwork, routine street cleaning and sanding and snow removal.

If this measure is approved, \$71,038 of the taxes levied in the 1983-84 fiscal year will be totally financed by local taxpayers without any partial State payment.

53. PARKS, RECREATION AND SWIMMING POOL OPERATING LEVY 1983-84 FISCAL YEAR

QUESTION: Shall City of Prineville levy \$105,429 outside its tax base for Parks, Recreation and Swimming Pool, Fiscal Year 1983-84?

EXPLANATION: In order to maintain the City parks system, renew operation of the swimming pool and provide certain recreation programs, \$105,429 in supplemental tax dollars are needed. More specifically, these dollars will be combined with other recreation related revenues to provide dollars for parks and maintenance personnel, maintenance and maintenance supplies, some few instructors, and lifeguards, chemicals and general operating costs in the swimming pool.

If this measure is approved, \$105,429 of the taxes levied in the 1983-84 fiscal year will be totally financed by local taxpayers without any partial State payment.


Section 3. That the City Council deems it advisable and does hereby call and make the necessary provision for holding special elections which shall be and are hereby called to be held on the 9th day of August, 1983.

The electors voting at said special election shall cast ballots on the levies outside the present tax base in the sums of \$131,000, \$71,038 and \$105,429, which shall contain, in addition to the ballot titles, the words " _____ YES, I VOTE IN FAVOR OF THE LEVY: _____ NO, I VOTE AGAINST THE LEVY," and on which ballots each voter shall mark and cast according to law as each may desire to vote.


Section 4. The City Recorder be and he is hereby instructed to publish a notice of election in full with the ballot titles therefor once or oftener within the time period established by statute immediately preceding said special elections in the Central Oregonian, the official newspaper of the City, and hereby designated for said purposes, the first publication of said notice to be not less than ten (10) days prior to said election and by posting written notice of the proposed tax levies outside the present tax base in the sums of \$131,000, \$71,038, and \$105,429 for the fiscal year commencing July 1, 1983 and ending June 30, 1984, in three public places: (1) Bulletin Board, City Hall; (2) Bulletin Board, U.S. Post Office, Prineville, and (3) Bulletin Board, Crook County Courthouse, Prineville, Oregon. The City Recorder shall make such arrangements with the Crook County Clerk as are necessary for the conduct of the elections.
