

RESOLUTION NO. 606

A RESOLUTION PROVIDING FOR SPECIAL ELECTIONS TO BE HELD ACCORDING TO THE STATUTES OF THE STATE OF OREGON AND THE CHARTER OF THE CITY OF PRINEVILLE FOR THE PURPOSE OF ADOPTING OR REJECTING A LEVY OF \$408,337 OUTSIDE THE CONSTITUTIONAL 6% LIMITATION; A LEVY OF \$11,494 OUTSIDE THE CONSTITUTIONAL 6% LIMITATION; PROVIDING FOR THE BALLOT TITLES, WHICH SHALL CONTAIN A CAPTION, QUESTION AND EXPLANATION CLAUSE; PROVIDING FOR THE TIME AND PLACE OF THE ELECTIONS; AND PROVIDING FOR NOTICE OF THE ELECTIONS.

THE CITY OF PRINEVILLE RESOLVES AS FOLLOWS:

Section 1. Special elections to provide for a vote on a General Fund, Street Fund and Parks, Recreation and Swimming Pool Fund operating levy in the amount of \$408,337, commencing July 1, 1983, and a one-year special levy for Airport maintenance in the amount of \$11,494, commencing July 1, 1983, shall be held and the same are hereby called to be held in the City of Prineville, Crook County, Oregon, Tuesday, June 28, 1983. These amounts are outside the present tax base.

Section 2. The ballot titles under which these proposals shall appear are as follows:

51. GENERAL, STREETS, PARKS, RECREATION, POOL OPERATING LEVY, 1983-84 FISCAL YEAR

QUESTION: Shall City of Prineville levy \$408,337 outside its tax base for General, Streets, Parks, Recreation and Pool, Fiscal Year 1983-84?

EXPLANATION: As authorized by the Oregon Constitution, the City can levy only \$81,650 in property taxes for the 1983-84 fiscal year and must have specific voter approval for any amounts above this level. In order to continue to provide the present level of services in the General Fund, Street Fund and Parks, Recreation and Swimming Pool Fund, supplemental tax dollars are needed. If this measure of \$408,337 is approved, it will provide the dollars necessary to provide the aforementioned services. More specifically, the \$408,337 will support the following: GENERAL FUND - \$151,382. Will help offset costs in areas such as Administration, Police and Fire protection, Ambulance services and Legal services; STREET FUND - \$100,969. Will help offset the overall costs of street maintenance; PARKS, RECREATION AND SWIMMING POOL - \$155,986. This includes dollars for parks maintenance personnel, maintenance and maintenance supplies, recreation instructors and equipment, and lifeguards, chemicals and maintenance supplies for the pool.

If this measure is approved, \$171,920 of the taxes levied in 1983-84 are eligible for partial state funding. However, \$237,417 of the taxes levied will be totally financed by local taxpayers without any partial state payment.

52. SPECIAL ONE-YEAR AIRPORT MAINTENANCE LEVY

QUESTION: Shall City of Prineville levy \$11,494 outside its tax base for airport maintenance?

EXPLANATION: Additional maintenance is needed in fiscal year 1983-84 at the Prineville-Crook County Airport on taxiways and parking areas. If this measure of \$11,494

is approved, it would provide dollars to match funds from Crook County and private sources to complete the aforementioned maintenance.

If this measure is approved, \$11,494 of the taxes levied in the 1983-84 fiscal year will be totally financed by local taxpayers without any partial state payment.


Section 3. That the City Council deems it advisable and does hereby call and make the necessary provision for holding special elections which shall be and are hereby called to be held on the 28th day of June, 1983.

The electors voting at said special elections shall cast ballots on the levies outside the constitutional 6% limitation in the sums of \$408,337, and \$11,494, which shall contain, in addition to the ballot titles, the words " _____ YES, I VOTE IN FAVOR OF THE LEVY: _____ NO, I VOTE AGAINST THE LEVY," and on which ballots each voter shall mark and cast according to law as each may desire to vote.

Section 4. The City Recorder be and he is hereby instructed to publish a notice of election in full with the ballot titles therefor once or oftener within the time period established by statute immediately preceding said special elections in the Central Oregonian, the official newspaper of the City, and hereby designated for said purposes, the first publication of said notice to be not less than ten (10) days prior to said election and by posting written notice of the proposed tax levies outside the constitutional 6% limitation, in the sums of \$408,337 and \$11,494 for the fiscal year commencing July 1, 1983 and ending June 30, 1984, in three public places: (1) Bulletin Board, City Hall; (2) Bulletin Board, U.S. Post Office, Prineville, and (3) Bulletin Board, Crook County Courthouse, Prineville, Oregon. The City Recorder shall make such arrangements with the Crook County Clerk as are necessary for the conduct of the elections.


